Privacy Notice

The purpose of the event is to inform you and your class pupils about further and higher education options through taster sessions with a chance to speak to current civilian and Service students about their own experiences. - All emails about the events will be sent to school staff using their school email addresses.
- Any attendees who have not pre-registered will be blocked from joining.
- Events will be recorded within the Zoom platform. The recording will be uploaded to ORGANISATION 1 website for individuals to watch after the event. Speakers from all participating organisations have agreed to this.

Details of the names of pupils attending this event and workshops within it, will only be collected and further shared if a Data Sharing Agreement is in place and only in accordance with the terms of that Agreement. Where no existing Agreement is in place, only numbers of attendees will be collected.

Participating organisations will be attending the event and may receive anonymous details of attendees and event feedback — namely ORGANISATION 3, ORGANISATION 2 and the SCIP Alliance.

Your name and school email address will be collected within the Zoom platform and processed securely by ORGANISATION 1 for the purposes of event administration, reporting and delivery.

If you choose to supply post-event feedback this will be anonymous.
